## Councillor loses committee roles

#### Only sanction available due to legal 'anomaly'

Acouncillor convicted of overspending during last year's elections has been stripped of his committee responsibilities.

Independent councillor
Alan Jack was subject to an
emergency motion during
Wednesday's full council
meeting. It also saw leaders
call for the closure of a legal
loophole which has allowed
the maverick politician to
remain in place.
The Almond and Earn

The Almond and Earn representative sat silently throughout the proceedings as his colleagues supported the motion put forward by leader Ian Miller.

Cllr Miller said there

Cllr Miller said there was no "personal malice" in the motion but that he felt that he had "no option" but to pursue it given the circumstances.

circumstances.

He warned: "Without action this could signal a free for all for people to breach rules for elections."

"It is with some regret I propose this motion. If Councillor Jack had done the honourable action and resigned his seat following his conviction, it would not

have been necessary."

The council leader hinted that the loophole, which means that councillors convicted in such circumstances are not required to step down, should be looked at again.

"This is a highly unsatisfactory situation and I think councillors should have deep concern at this situation." said CIL Miller.

have deep concern at this situation," said Cllr Miller.

"My view is that I would have liked to have done more, but this is the only maximum sanction available."

Councillor Peter Barrett added that over and above the motion, other steps with regulatory bodies should be carried out to prevent a repeat. He also pointed out that had the offence been committed in England or Wales, the renegade ex-Tory would have been removed, but there was said to be an 'anomaly' in Scots Law.

The decision was not put to the vote, instead councillors verbally backed the motion.

Cllr Jack (74), of Bridge

Cllr Jack (74), of Bridge of Earn, was fined £450 at Perth Sheriff Court last month for exceeding the maximum limit for election expenses.

He admitted spending £850.64 more than he should have between March 22 and May 26 last year in his bid to get elected as an independent councillor.

Following Wednesday's meeting, Cllr Dave Cuthbertwill nowsit on the development management committee, Cllr Mike Barnacle on enterprise and infrastructure and Alan Livingstone on the Tayplan committee.



# 'It seems candidates can now buy seats'

PKC's leader wanted Cllr Alan Jack to resign following his election fraud conviction.

No legal action can be taken to remove the Almond and Earn maverick from office and council figurehead lan Miller fears the episode could lead to the "wholesale abuse" of election expenses in the future.

"If this happened in England, he would have been automatically disqualified as a councillor, as the law intended," he said.

"However, there is no provision for this in the Scottish version of the Representation of the People Act. This creates a worrying precedent and could lead to wholesale abuse of election expenses at the next local government election.

"The limits on

election.

"The limits on spending are designed to ensure there is a level playing field for all candidates. That may not be the case in future as it seems candidates can now buy 'their seat and then face a fine of only £400 with no further

nction.

"This seems ridiculous to me. Section 2.1 of the Councillors' Code of Conduct states, 'You have a duty to uphold the law and act in accordance with the law and the public trust placed in

you.'
"That has clearly not been the case here."

The leader of PKC's
Tory group Mac Roberts
added: "Further to the
legal opinion that there
are no sanctions
available to penalise
Councillor Alan Jack for
exceeding the maximum
amount for election
expenses by £850 – even
though this was money
from his own pocket –
some people may think
that it is a minor matter.

"However, this is unfair to all other candidates. We do not want to get to the position where people can buy electoral success just by having a large wallet.

"With no legal
sanctions available it is
now up to Councillor Jack
to consult his conscience
as to his future."
